- 1 The application form must be filled by the applicant himself/herself in his/her own handwriting and signed.
  - 2 The application must accompany the eligibility fees, as given below, in cash :-
  - a) Rs. 50/- for the applicants passing the exam. from the Boards/Universities situated within the Marathwada region.
  - b) Rs. 100/- for the applicants migrating from outside Marathwada but within the State of Maharashtra.
  - Rs. 500/- for the applicants migrating from the Boards/Universities out of Maharashtra. i.e. other states
    of India.
  - d) Rs. 12,500/- for the applicants having Foreign Nationality.
- 3 The application must accompany the following ORIGINAL certificates alongwith the attested zerox copies of the same:
  - a) Migration Certificate of the University from which applicant has passed the latest examination.
  - b) Final Marklist of the qualifying examination OR Provisional Passing Certificate.
  - c) Caste Certificate from the competent authority showing caste and category.
  - d) Transfer (Leaving) Certificate, if necessary.
  - e) S.S.C. Certificate showing date of birth, if necessary.
  - f) Degree Certificate or Provisional Passing Certificate for admission to Post-graduate Degree or Diploma or Ph.D.
